CAMPO'S SONG set the pace off the inside, extended his advantage in the stretch under a mild drive. ANHOUROFHONOR saved ground off the pace and continued well to the finish. PATERNO chased in the two path, steadied briefly on the turn then angled wider into the stretch. RON THE LAWYER saved ground throughout and closed a gap through the stretch. CASH OR CREDIT chased five wide and gave way on the turn. FAIRY SNOW chased in the two path and lacked a rally. RICK'S CAFE prompted the pace outside then stopped. A claim of foul by the finisher against the winner for interference on the turn was dismissed by the stewards.
