SONS OF MISSOURI chased in mid-pack, angled inside advancing in the stretch and was up late. SHAMADAAN forced the pace between rivals, held a narrow lead to the final sixteenth but was unfinished. FROZEN FOUR held a slim advantage four wide to the turn, dueled then weakened late. RON THE LAWYER dropped far behind then offered some late energy. WHIRLING DERVISH raced very wide and continued well while no threat. STRAIT SMILE broke slowly, moved inside, angled wide on the turn and faded. CLUCK FOR BUCKS was outrun racing wide and gave way. GLADIATORS SHOT prompted the pace near the inside and proved empty in the stretch. REALIST dueled between foes to midway on the turn then stopped.
