SONJA'S ANGEL very wide racing into the first turn, took command under rating, moved closer to rail, drifted out entering the lane, drifted again, while clear, deep stretch and edged away. STARSHIP GIRL, outside and just off the pace, challenged on the final turn, was unable to match strides late. OUR QUIET HANNA, outside and never far back, bid on the final turn but then flattened out. ZAPHYRA, well placed between foes, tired. BE MY CANDY vied for command between foes and tired. AT FIRST SPEIGHT failed to menace. HOTBUTTEREDPOPCORN saved ground and tired. A CLAIM OF FOUL BY THE RIDER OF STARSHIP GIRL AGAINST SONJA'S ANGEL FOR ALLEGED INTERFERENCE IN THE STRETCH WAS DISMISSED.
