HAS DETERMINATION saved ground, rallied to the lead entering the lane, drifted out while extending her margin and was fully extended to the wire. RUMBLE SEAT challenged three wide on the turn but then was no match. BELLE OF THE WEST saved ground and failed to menace. TOURLIANI set the pace well off the rail and tired. LIGHTNING LINDSAY was always far back. DANCIN DEVON ROSE was pulled up in distress in her left hind in the opening furlong and was vanned off. PATRICAS DREAM injured herself in the starting gate and was ordered scratched on the advice of the veterinarian. All wages on her were refunded. NUMEROUS PROBLEMS LOADING THIS FIELD CAUSED A FIVE MINUTE DELAY IN POST TIME.
