LADY DURLYN settled off the pace outside, progressed through the turn, took over four wide at the top of the stretch, raced clear nearing the eighth pole and under steady encouragement to widen. BEHOLD A LADY, just off the pace toward mid track, came under a drive while saving ground from the three eighths pole and dug in through the lane to get the nod for place. DANCING MOMENT stalked the pace off the rail, pressured the pacesetter approaching the turn, took a slim brief lead at the five sixteenths pole, dueled close in the upper stretch, yielded the final furlong and missed the nod for place. KINTOABANKER rated back outside, made a mild four wide bid on the turn. PRECIOUS JANE showed no speed well back then passed tiring rivals. SHERI'S GOLD took over approaching the three quarter pole, rated the pace inside through the backstretch, came under pressure at the three eighths pole then weakened from the quarter. DESIRABLE DESIREE steadied leaving the gate and was not a factor. MARIA'S STORY, off the pace and off the rail, lost some ground entering the stretch, was eased late and appeared sore upon return.
