RES JUDICATA set the pace just off the rail and edged away. PIQUANT drifted out leaving the turn and again on the turn, split foes in stretch for place. FOLLOWING A CLAIM OF FOUL BY THE RIDER OF PHIL DANCER, PIQUANT WAS DISQUALIFIED AND PLACED FIFTH. HIGH ON CANDY prompted the pace outside winner and faded. ESCROW KID raced outside, was carried wider on the turn. PHIL DANCER eased back after an alert start, steadied in a bit tight on the far turn, moved inside and failed to menace.
