SHOCK APPEAL moved clear in the opening furlong, extended her lead on the turn and kept to a mild drive. REBEL WAYS chased wide, advanced on the turn and closed well while no match for the winner. OH RAMBLIN ROSE drifted out in the opening stages causing crowding, raced close up then tired. INDEPENDENT LADY raced close up between rivals then gave way through the stretch. M SQUAD dropped back early then passed fading rivals. CREVETTE raced wide and lacked a rally. COOKIE JAR gave way along the inside. DEAR OLD DONEGAL was fractious in the gate unseating her rider then gave way readily. MISS TEA PARTY clipped heels early and fell. Following a stewards inquiry, OH RAMBLIN ROSE was disqualified and placed last for interference in the opening yards.
