BLAZEN well positioned off the dueling pacesetters, bid to the front into the lane and edged clear. JUDGE WELL held a narrow lead outside to the stretch then yielded in a good effort. GIOPI (IRE) vied inside to the stretch then came up empty. DEPUTY DILLON chased outside and lacked a rally. FISHERMAN'S WHARF saved ground throughout, moved closer near the far turn then faded. DIXIE EMPEROR raced within striking range three wide but was finished after half a mile. DRAGONFISH trailed throughout and was being eased through the final furlong.
