DEVIL'S LIL BIT stalked the pace while never far back, rallied into the stretch and took the lead, drew clear under heavy pressure. CINCY SIN dueled for the lead and set the pace, drew off on the turn, faltered and could not go with the winner, was second best. CATPACHINO was well placed in mid pack, ran evenly and had no rally. TIGHT MONEY was void of early speed, improved position but was no threat. DOC NORVELL pressed the pace and dueled for the lead from the outside, faltered in the stretch and faded. MORNING STAR MIMIC failed to menace. IN CASE OF SNOW flashed brief speed before fading.
