PIONEER TIME stalked the pace to the outside, rallied on the turn and dueled for the lead, drew clear late under heavy pressure. LOOKS RIGHT set the pace while off the rail, dueled gamely to mid stretch, was no match for the winner but was second best. SARINA'S PRINCESS pressed the pace and dueled for the lead, weakened in upper stretch and began to fade. PLEASE TELL was void of early speed, improved position in the stretch but was no factor. FEBRUARYS LADY failed to menace. DRIVING ROSA WILD was off slowly, was rushed to contention, was wide and lost ground, gave way in the stretch.
