DOWER was void of early speed, had a late rally in the stretch and was gaining but too late, just missed. FLY UNITEDLY dueled for the lead and pressed the pace, was steadied in upper stretch, came again late and had some late gain. HOOEY dueled for the lead and set the pace, faltered in the stretch and faded. NATALMA'S LIGHT was well placed on the inside, ran evenly with no rally. THE BIG WHAMMY was in a good stalking position in mid pack, ran evenly with no rally. ELLIDAY flashed brief speed, stopped and dropped back.
