### Footnotes

I REMEMBER WHEN stalked the pace with good early speed while off the rail, rallied on the far turn and drew clear in upper stretch, was all out to hold sway late. TELLMENICETHINGS was in a good stalking position while four wide, rallied into the stretch and loomed a threat, flattened out and ran evenly late. TURBO JUSTICE set the pace with good early speed while off the rail, faltered in the stretch and faded. PREACHER was void of early speed, rallied into the stretch, failed to sustain the bid and ran evenly late. ANGEL HOPE was unhurried early, improved position but was no factor. DAKOTA DIM showed good early speed while four wide, gave way and dropped back. MY TWO ROSES failed to menace. FANTASTIC MADAME was no factor. ASIAN PROVERB showed good early speed chasing the pace, weakened and faded. JO JO JUICE showed good early speed chasing the pace, was through after a half mile and was eased in the stretch.
