MAGICAL COURT was unhurried early while five wide on the turn, rallied into the stretch and was all out to get up in the final strides. WILL E SCAT was void of early speed, had a late rally in the stretch and led in the final jumps, was outfinished to the wire. DELTA CHARLIE dueled for the lead and set the pace, drew off in upper stretch, weakened and ran evenly late. ICANDAZZLE dueled for the lead and set the pace, rallied on the turn, flattened out and ran evenly late. PUTMEUPFRONT was in a good stalking position in mid pack, ran evenly with no rally. MR. RAVEN failed to menace.
