CATLAUNCH set all of the pace while off the rail in the three and four path, responded when challenged on the far turn and drew off while under constant urging. PYRITE PERSONAL stalked the pace while never far back, rallied on the second turn, failed to sustain the bid and ran evenly through the stretch. ALLSAROTT was well placed in mid pack, rallied on the second turn, hung in the stretch and began to fade. SNEAK A COLD TREAT was in a good stalking position and showed good early speed, gave way and dropped back. CAJUN PRIZE was unhurried early, ran evenly with no rally. HURLEY'S WAY was no factor, improved position in the stretch. ACTS LIKE A KING stalked the pace with good early speed, faltered and faded. RAISE THE REWARD failed to menace while wide and lost ground. MR EASY E was no threat. DINKERS CLASS ACT was no factor.
