KENTUCKY PRESENT stalked the pace while never far back on the outside, rallied into the stretch and drew off, was under heavy pressure to hold the margin late. RECKLESS CAPOTE dueled for the lead and pressed the pace, could not go with the winner in the stretch, ran evenly late and lacked the needed closing response. FRIENDLYACCUSATION dueled for the lead and set the pace, faltered and faded. PAYING THE BILL was void of early speed, improved position but was no factor. CARR POOL flashed brief speed before stopping. CHOCOLATE MARINI failed to menace.
