RAKEEN ORATORY set the pace with good early speed, led to late stretch and was outfinished to the wire. HOUND TOR was unhurried early, had a late rally and was gaining but too late. SAINT CHOCOLATE was void of early speed, also had a late rally and was gaining but too late. FULLO SUCCESS showed good early speed, gave way and dropped back. RUNAWAY DIXON showed good early speed, was through after a half mile and dropped back. ROCHESTER CAT flashed brief speed before stopping.
