### Footnotes

MY BEST CHANCE was in a good stalking position while four wide early, rallied on the far turn and into the stretch, was all out to hold sway late. TSUNAAMI STU was unhurried early while saving ground, scraped and brushed the hedge through the stretch, had a late rally and was gaining but too late. ESPRESSO JOE set the pace with good early speed while well off the hedge, weakened in the stretch and ran evenly late. SWINGN SLEW dueled for the lead and prompted the pace, gave way and dropped back. STOP THE THUNDER failed to menace. CAME TO SCORE showed good early speed chasing the pace, faltered and faded. FREEPORT BAY was no factor. DISSONANCE showed good early speed while four wide, gave way and dropped back. MOVE ON UP was no threat.
