UPUPANDGO was unhurried early while saving ground, rallied into the stretch and split horses, drew clear under constant handling. NOT ENUFF JUSTICE dueled for the lead and set the pace while off the rail, weakened in late stretch but was still second best. PART GIRLIE GIRL dueled for the lead and set the pace, faltered in the stretch and faded. INSIGHTFULLY was well placed in mid pack, ran evenly with no rally. ERIN AND AVA was unhurried early, passed tiring rivals. SEPTEMBER CEREMONY was well placed in mid pack, ran evenly with no rally. STAR AWARD failed to menace.
