IAIN'TMADATCHA pressed the pace, rallied into stretch, hooked in a prolonged drive to the wire and prevailed gamely. BLUELIGHTS N SIREN good speed, dueled early, cleared into the lane, dueled through the final furlong and lost the lead in the final jumps. FAST DEPOSIT had good position, made a menacing move at the quarter pole but evened out in the late stages. MOCC ME NOW was well back early, rallied into stretch from off the rail and moved up late. DEL MAR STORM well back to the quarter pole, shifted outside and made up ground through the stretch improving position too late. SULTRY PLEASURE failed to menace. PROMISE HER DAMOON was up with the pace to the quarter pole, began to retreat from that point and gave in. PRIZE MONEY was off slow and no threat. EQUIVOCAL had a steady fade.
