CHILD PROOF was unhurried early in mid pack, was angled out into the stretch and rallied, drew clear under constant urging. RITA'S ROSARY dueled for the lead and pressed the pace while saving ground, weakened in the stretch but was still second best. CHELSEA'SMOUNTAIN dueled for the lead and set the pace, faltered in the stretch and faded from the outside. WHAT ABOUT MAEVE was void of early speed but did improve position. LICORICE TWIST failed to menace. NORTHERN SECRETARY showed good early speed, was through after a half mile and gave way readily in the stretch.
