CHARLES EDWIN was settled early then saved ground on the turn while making a run, angled out to be three wide in upper stretch and powered to the front in late stretch. JOE MOVE was sent along from the start to set the pace, drew off going into the turn then was all out but weakened in late stretch while holding the place safe in the end. KRISTYS BOONESMILL chased the pace while saving ground on the turn then made a two wide bid in upper stretch but hung in late stretch. GARBU ROAD was three wide on the turn and made a bid then raced evenly in the stretch. LUCADO was two wide on the turn and settled, tried to bear out then failed to respond in the stretch. GRAND CASA was unhurried early then was five wide in upper stretch and failed to menace. JEFF KENTUCKY was four wide on the turn and made a bid then faltered in the drive. DE ICE CAT raced three wide on the turn and was no factor. SUPER STRUGGLER chased the early pace while racing two wide on the turn, was used up and gave way in the stretch drive. FIGHTIN RUCKUS raced on the inside on the turn and was no factor.
