A STEWARD'S INQUIRY WAS HELD CONCERNING THE START. AFTER REVIEW: SHAZOOMS SWEET BRUJA WAS DISQUALIFIED FROM 6TH AND PLACED 9TH FOR INTERFERENCE AT THE START. A JOCKEY OBJECTION WAS LODGED BY ARTEFACTZ AGAINST ORIONS AWARD FOR INTERFERENCE AT THE START. AFTER REVIEW THE OBJECTION WAS DISALLOWED.
