MFAZI dueled on the inside, pulled clear while off the rail near the five-sixteenths marker and drew away under steady right hand urging. MR. QUESTION chased the pace on the outside then four wide on the turn and proved no match for the winner while clear for the place. ROLLMEASEVEN was urged along on the outside, raced five wide on the turn and came up empty while best of the rest. TIME was well placed just off the pace, dropped back while off the rail on the turn, moved to the rail near the quarter-pole and faded. TEAMUP bumped with a rival at the start then again after the start, was ridden along while off the pace, raced three wide on the turn and failed to threaten. MR JAW TALK was urged along between rivals, raced four wide on the turn and also failed to threaten. SIR CRAFTY bumped twice with rivals after the start, raced well off the pace, went four wide on the turn and was no factor. ADOPTION bumped with SIR CRAFTY after the start, settled off the pace, raced off the rail on the turn and never reached contention. GATE OVATION was ridden along on the inside and saved ground to no avail. DANCING SAVAGE was void of speed, raced three to four wide on the turn and showed little. CRAFTY SAN PEPPY

raced well back in the field, went five wide on the turn and also showed little. KICKAPOO KID was bumped at the start, dropped well behind the field, raced off the rail on the turn and was outrun. SUNNYGETTHEMONEY dueled on the outside, dropped back on the turn and stopped then pulled up sore in the final furlong and was vanned off.
