RED GAL'S BOY was allowed to settle in the early going while inside, rallied heading into the far turn and moved out to be four wide, quickly moved to the front in mid stretch and widen that advantage in late stretch. MY ORDEAL was unhurried early then started a run into the far turn, rallied five wide on the far turn making a bid to mid stretch but was no match for the winner in late stretch. FIREBALL'S ACE was allowed to settle on the run down the backstretch then rallied three wide into the far turn, gained command in the middle of the far turn but failed to sustained that bid in late stretch. VOYAGERS STAR was unhurried early then rallied three wide on the far turn, bumped with EARLY ROCKIN in upper stretch then came up empty in late stretch. U GO ROY dueled for the early lead from the inside, was used up then gave way in upper stretch then was bumped from behind by EARLY ROCKIN and stopped in late stretch. EARLY ROCKIN was unhurried early then moved to the inside on the far turn, moved out to be two wide then was in tight quarters and bumped with VOYAGERS STAR and U GO ROY in upper stretch, losing the whip in the process then was again in tight quarters in mid stretch from between rivals and flattened out in the end. SEBASTION dueled for the lead while two wide, was hard used then stopped on the far turn. A stewards inquiry as held concerning the stretch drive. A trainer claim of foul was lodged by the trainer of EARLY ROCKIN against the rider of VOYAGERS STAR for interference in upper stretch. After reviewing the films, no action was taken.
