CALCULATED MOVE had his heels clipped on the run down the backstretch then raced two wide on the turn and failed to menace. ROYAL VALID bore out on the run down the backstretch and bumped with LOTS OF PURPOSE then was no factor. LOTS OF PURPOSE was bumped on the run down the backstretch and forced out then clipped the heels of CALCULATED MOVE and stumbled then trailed throughout. A CLAIM OF FOUL WAS LODGED BY THE TRAINER OF LOTS OF PURPOSE AGAINST THE RIDER OF CALCULATED MOVE FOR INTERFERENCE ON THE BACKSTRETCH. AFTER REVIEWING THE FILMS, NO ACTION WAS TAKEN BY THE STEWARDS.
