**Footnotes**

B'WANAGOLDMINE was allowed to settle on the run down the backstretch, started a run heading into the far turn then was forced to angle out three wide and bumped with rivals, rallied three wide in upper stretch and closed fast on the outside to be up in the final strides. WALKWAY dueled for the lead while inside, drew off in mid stretch then was all out in late stretch but was caught in the shadow of the wire. FAVORITE JAZZ was inside on the run down the backstretch, rallied on the far turn then swung out to be four wide in upper stretch then closed willingly in late stretch. DOVE EXPRESS stalked the pace while racing three wide on the backstretch, rallied four wide on the far turn making a bid to mid stretch then came up empty in late stretch. WAYLAY was unhurried early and passed tiring rivals in the stretch drive. BG SILVER SNOW was allowed to settled then raced inside on the far turn and made a mild gain in the stretch drive. WINCHESTER BAY pressed the early pace while racing three wide on the backstretch, angled inside on the far turn making a bid

in upper stretch but faltered in the drive. STORMING OVER IOWA raced four wide on the backstretch while in good position, was used up and gave way on the far turn. ONE TOUGH BUCK was allowed to settled on the backstretch but failed to respond when asked. STREET POSITIONING was unhurried early while racing five wide on the far turn then was no factor. DANCIT was allowed to settled then started a run while four wide into the far turn, was bumped and stopped in the stretch. ONE SLEET DEAL dueled for the early lead while two wide, was used up and stopped when entering the far turn then returned bleeding.
