SMILES GOLDEN SONG was in the early lead group and was three wide in the clubhouse turn, was pushed along at the quarter pole and broke from the field while three wide, drew strong handling the rest of the way in and was a driving winner. SASSY DELIGHT was one of the early leaders heading into the near turn and was two wide, dueled for the lead down the backstretch and came under the whip when the leader drew away leaving the turn, traveled two wide in that final bend and maintained second place. DEFIANT RED maintained a contested spot along the rail for the first turn, looked for racing room in a spot four wide in the second turn and ran determinedly for third. B G COUNTRY GIRL was another to contest the early pace and was forced five wide in that opening bend, pressed the leaders down the backstretch, came under the whip nearing the quarter pole where five wide, but had nothing left to mount a winning bid after that. DONEGAL GOLD contested the early pace and was four wide in the first turn, failed to advance upon the lead group and was five wide in the second turn before tiring. SEA OF DREAMS broke outward at the start before shuffling in and taking the first turn two wide, had a rail trip through the second turn and slowly advanced in the final stages. MY COUSINS AND ME reared coming out of the starting gate and was bumped, took the first turn four wide while trailing the field and soon tired. TIGER'S SPLENDOR had racing room toward the inside but was shuffled outward for a three-wide trip through the opening turn, was restrained under a tight hold down the entire backstretch, allowed to run at the three-eighths pole while two wide but finished last. SASSY DELIGHT WAS DISQUALIFIED FROM SECOND TO UNPLACED FOR A MEDICATION VIOLATION.
