WINTER DRIVEN was bumped at the start then settled on the run down the backstretch, rallied on the inside on the turn, angled out three wide in mid stretch while in a strong drive and proved best in the end. NIGHT LADY vied for the lead while two wide on the backstretch, rallied and drew off in mid stretch then was caught in late stretch. LIL LADY TEE vied for the lead while four wide on the backstretch, had it's heels clipped nearing the top of the stretch, then lacked a late bid in the stretch. MALGENIADA vied for the lead while inside, was in a long drive then weakened in the stretch drive. BECKY'S DELIGHT chased the early pace while racing inside, stayed on the inside on the turn then failed to menace in the stretch. DARLING'S GENERAL was bumped at the start then raced on the inside on the turn and was no factor. STRONG LADY was bumped at the start then was taken up, was settled while racing four wide on the turn but was no factor in the stretch. MISSREMITIN dwelt at the start then moved to the inside after be rushed to rejoin the field then was no threat. FIRST SERVE vied for the early lead while three wide into the turn, bore out on the turn and clipped heels then faltered in the stretch drive. PEACEINTHESPIRIT was six wide throughout and outrun. DO'S DEVIL CAT was five wide into the turn and was no factor. C R GIRL GO broke in and bumped at the start then was five wide on the turn and no factor. A claim of foul was lodged by the rider of FIRST SERVE against the rider of LIL LADY LEE for interference nearing the top of the stretch. After reviewing the films, the stewards took no action.
