NEXT MAP vied for the early lead while two wide then dropped back heading into the turn then rallied and came again in the stretch while three wide, was in a strong drive on the outside and proved best in the end. BUMP'S MAGIC CAT was two wide on the turn then rallied, moved up behind rivals and was blocked in upper stretch, waited for racing room then angled out in mid stretch and was gaining ground in late stretch to be second best. QUIET DOMINATION vied for the lead while two wide, was in long drive on the turn, was in a long drive then bore out in mid stretch and weakened in late stretch. STREET PURPOSE vied for the lead while inside, was hard used on the turn then tired in late stretch. DOWNTOWN CALFCREEK was inside on the turn then made a mild rally while two wide in the stretch but was no threat. SHILOH'S DREAMMAN was settled then rallied on the turn while four wide making a bid then flattened out in late stretch. SEATTLE STREETS was allowed to settle then rallied three wide on the turn, made a bid then was no menace in the stretch. COOPERS GULCH was inside on the turn and saving ground, made a bid to upper stretch then weakened in the drive. DEMIS CLEVERCHANCE raced six wide on the turn but was no threat. TEXAS REBEL was five wide on the turn then faltered in the stretch. HAWAIIAN RED BIRD was six wide on the turn and was outrun. HAL TO TRICKY was inside and outrun. A claim of foul was lodged by the rider of BUMP'S MAGIC CAT against the rider of NEXT MAP for interference in upper stretch. After reviewing the films, no action was taken.
