BAILEYS GULCH vied for the lead while five wide, rallied on the turn then was in a long hard drive and proved best in the end. TINCY vied for the lead from the inside, was in a long drive and tired in late stretch. UNA MAS FUEGO vied for the lead while four wide, was hard used and weakened in the stretch drive. SENECA STALKER rallied five wide on the turn and made a mild gain in the stretch drive. GOLD STREET broke slowly from the gate then made a rally while five wide on the turn and was gaining ground in the stretch but was no threat. CATAPULT SHOT as three wide on the turn then was bumped in the middle of the turn and was no menace. BAMA SLEW was two wide on the turn and bumped then steadied off heels and was no threat in the stretch. JUS' CRUIZEN was inside on the turn and was no factor. THRILLIGAN vied for the early lead while two wide, was used up and stopped on the turn. EASTER STRIKE vied for the lead while three wide, was hard used and stopped on the turn.
