ADMIRAL KITTEN was content to let others press the pace, remained unhurried and two wide in the opening turn, was shaken up approaching the quarter pole, circled four wide nearing the completion of the final turn, came under a left-handed whip nearing the eighth pole and was a driving winner. WORLDVENTURER stalked close behind the lead pair, stayed close while two wide at the first bend, set sights on the lead with a move past the three-eighths marker, stayed two wide while advancing through the turn, was on even terms with the leaders at the eighth pole and gamely finished second. MR. MCCOY was allowed to press the early lead, went through the first turn two wide, came under a hold leaving the first turn with the lead, was given a shake of the reins at the quarter pole while racing along the rail and was outfinished while in contention in late stretch. Z MAITRE D was eager to pursue the early lead but was carried out four-wide trip through the first turn, waited for room at the quarter pole, guided out three wide leaving the turn, angled out at the top of the stretch and made a belated rally. JUMP FOR KITTEN pulled the rider in front of the grandstand the first time around, veered out to be three wide entering the turn, stayed in that position through the second turn but raced evenly in the stretch. TEXAS BLING pressed the pace but in a hold heading to the first turn, had the rail in the first turn, was allowed to run after the opening half mile, was two wide in the second turn before angling in leaving the quarter pole, was asked for more while within striking distance at the top of the stretch but was outfinished. TARMAC was far back and trailed until passing a tired horse late. SEEKING PAYDAY went to the lead under restraint, had the rail spot in the first turn, remained in that spot but lost ground through the second turn, checked entering the stretch and stopped.
