NAEVUS GIRL was pushed along quickly at the rail and challenged for the lead, kept rail through turn, kept busy in stretch for a driving win. ISLAND ARTIST pressed the pace, steadied at the three-eighths pole, quickly regained stride but was caught three wide in the turn before making a nice rally in the stretch. STORMY DONNA GAIL was sent to duel with the early leader, loomed a threat while two wide in the turn, mild rally. SUZY THREE went to the lead, challenged entering the turn, two wide, tired in the stretch. DONEGAL GOLD reared at start and was unhurried, five wide in the turn, angled out for room in the stretch, rallied. B G SISSY'S GIRL settled in midpack, three wide in the turn while caught behind a rival, angled in to the rail for the run down the stretch and responded with a late rally. BRAZZLE DAZZLE was asked to keep up, advanced but was five wide in the turn and had no impact late. SLAMMING stalked, had the rail through the turn while still in contention, tired. TIGER'S SPLENDOR broke awkwardly, rushed up in an effort to press pace, waited behind runners at the three-eighths pole and was done. FAPIANO QUEEN was outfooted early and soon fought the rider before reaching the first turn and was no in contention.
