SWEET LITTLE CAT was nudged to keep close to the leader, was six wide in the turn, got a right-handed whip not even to the three-sixteenth marker and finally prevailed after a stretch-long drive. SEA OF DREAMS was put under the whip in the first few jumps away from the starting gate, ridden for more speed to reach the lead in short order, was four wide in the turn, drifted out at the sixteenth marker under the right-handed stick yet was outfinished in the final yards. P K'S PHILLY challenged the early leader from the outside, remained out wide while in close contact with the lead runner, five wide past the quarter pole, contended at eighth pole, altered course in the final sixteenth and settled for third. I'M SPECIAL found a spot in midpack, came in tight quarters at the seven-sixteenth marker, was back in full stride at the three-eighths pole, was about four wide entering the turn but cut the corner to be two wide approaching the three-sixteenth marker before hanging through the stretch. LILY'S PRAYER was bumped at the start, shaken up for run and soon given a few taps with the whip, four wide in the turn and had no rally. RED BIRD RULES two wide in the turn, no threat. MISTY VISIONS was allowed to pursue the lead, was pushed along by the rider through the turn with a rail trip but tired. MISS ARANZA traveled along the rail in the turn but was never a factor. An inquiry, followed by a rider's claim of foul with the jockey on P K's PHILLY objecting on the jockey of SEA OF DREAMS for interference in the stretch, was posted. There was no change in the final running order.
