## **Footnotes**

DAKOTA ADIEU stalked, was four wide in the turn, came under left-handed urging at the top of the stretch, drifted in at the eighth pole, continued under left-handed urging, responded and drew away with a clear win. KELLVILLE was ridden along in midpack, slow to advance and was four wide behind rivals in the turn, split horses with a rally in the final sixteenth and gamely continued on to the wire. LADY POSSE was ridden along in midpack, advanced at the quarter pole but got caught five wide in the turn and hung in that position late in the stretch. B G COUNTRY GIRL was ridden along to press the pace, was three wide in the turn and raced evenly in the stretch. WATERTOWN ROAD was content to trail early, two wide in the turn while still back before making a mild bid. CATO MAJOR settled toward midpack, traveled along the rail in the turn and failed to rally. PHARME'S PHIRE was content to trail early, four wide in the turn and made no advance. I'M SPECIAL reared at the start but was quickly sent to challenge for the lead, was two wide in the turn and stopped. SMOOTH SEA settled toward the back, was four wide in the turn, soon trailed.
