Starters to pay \$500 additional with \$50,000 included from the Oklahoma Breeders Fund and \$50,000 guaranteed by Remington Park of which the guaranteed monies to be divided 60% to the owner of the winner, 20% to second, 11% to third, 6% to fourth and 3% to fifth. The Oklahoma Breeders Fund included monies to be divided 45% to the owner of the winner, 25% to second, 15% to third, 10% to fourth and 5% to fifth. Weight: Three Year Olds, 122 lbs.; Older, 126 lbs. Horses with the highest accumulated 2008-2009 earnings according to official statistics provided by Equibase will have preference at time of entry. Starters to be named through the entry box by the usual time of closing. This race will be limited to eleven starters. A suitable award will be presented to the winning owner.
