PARKLANE CALL TIME set the pace while being pressured all the way, held well while racing fully extended. SILVER I. D. pressured the leader but could not clear, gamely outfinished. MARSHALLTOWN raced five wide, stalked pace but came up empty. TEJAS CAT void early speed, was allowed to settle,made a middle move but failed to menace. BREEZIES SPIRIT bumped start, was allowed to settle, closed willingly but no factor. V. EIGHT failed to respond. HE'S MY HUBBLE showed little. TOMAHAWK CREEK broke in, bumped foe, stalked pace, through after half. COUNTRY SCHOOLIN' brief speed, stopped. FREE AND PRETTY trailed, dull effort. LT. DAN FLAG never a factor. THEBARNYARDFERRARI outrun.
