ALSVID rated along inside early, came off rail four wide into stretch, responded to steady handling to gain command and drew off in late going. OKIE RIDE stalked leaders on the outside from outset, rallied between foes to loom danger mid stretch, weakened in late going. APPREHENDER broke to front, set pace into stretch, went gamely in drive before tiring in late going. JOE HOLLYWOOD chased pace into stretch while racing between foes, gave way. FLAT BLACK was never far back, came five wide to loom danger into stretch, faded. UNO DUCKSY was not a factor. DELIVERER never threatened. SOLAR CHARGE was outrun.
