FOR THREE YEAR OLDS AND UPWARD NO NOMINATION FEE. \$1,500 to pass the entry box and an additional \$1,500 to start (the start fee will be waived for any horse starting in the 2012 Texas Mile and/or 2012 Lone Star Park Hcp) with \$200,000 guaranteed with \$110,000 to the owner of the winner, \$38,000 to second, \$20,000 to third, \$11,500 to fourth, \$5,500 to fifth and \$3,000 for placing sixth through tenth. If less than ten horses start, the purse money not distributed will revert to the winning owner. Three-Year-Olds, 118 lbs. Older, 124 lbs. Non-winners of a Sweepstakes in 2012 allowed 2 lbs. \$30,000 at a mile or over twice in 2012, 4 lbs. \$30,000 at a mile or over in 2012, 6 lbs. ALTERNATION broke alertly, engaged in a duel while on the outside of rival from outset, responded to steady handling throughout stretch drive, prevailed in the end by the narrowest of margins. PRAYER FOR RELIEF broke sharply to gain narrow edge from start, went gamely under pressure throughout and just missed after a long hard stretch drive. GET IN DA HOUSE trailed for three quarters, passed tiring rivals in lane. DREAMINOFTHWIN forwardly positioned into stretch, lacked rally. STACHYS within striking distance along inside into stretch, had no rally.
