P F DON D broke sharply, sprinted to a clear lead, responded to strong handling when pressured in drive and held on in a gutsy performance. ERNESTO allowed to settle early, worked way forwardly along rail, swung six wide into lane, finished with a strong rally and was getting to winner late. BREGO chased pace to mid stretch, weakened in late going. MOTION APPROVED in back during early running, moved up along inside entering stretch, lacked needed response in drive. NOTABLE OKIE failed to menace. WILD SERIES raced in middle of pace and not a factor. HADACURE chased early pace long rail, gave way after a half.
