SERENA VENUS broke alertly to take command along rail before half, responded to pressure during stretch run and prevailed under steady urging. DONNAZERI within striking distance from outset, came four wide into stretch, responded to urging and gaining on leader in late going. DEMO SESSION well positioned while outside rivals from outset, raced three wide into late while within striking position, lacked responded in drive. SERAZZELL forwardly positioned outside rivals from start, came five wide into stretch, had no rally. VISION QUEEN forwardly positioned along inside during early running, failed to menace. UNCLOUDED DAY stalked leaders while racing mid pack into stretch, gave way. CAUGHTUPNTHEMOMENT wide of rivals from start, never a factor. OUI OUI ANN saved ground to no avail. RIO CATTY wide from outset, never a threat. SPARKLING APPEAL well back from start, had no response. JET LOVER was outrun. PREFER'S FLICKA hustled to front along rail, faded steadily after quarter mile.
