MARQ FRENCH pressured three quarters while going with the winner, was hard used and gave way. MOTION APPROVED showed little, failed to menace. HERECOMESTHEMANNOW never a factor. ZEE OH SIX showed brief speed and tired. GEORGE TAYLOR trailed and failed to respond.
