CAPTAIN CHEROKEE stalked leaders from outset, responded to gain narrow edge in late going while racing between foes, went gamely only to be outfinished in the end. CHIEF OF AFFAIRS dueled on the outside of rival into stretch, tired in lane. HUMBLE SMARTY hustled to front along rail, set pace for half, gave way in lane. DUCKY DRAKE trailed fore half, failed to menace. SOLAR CHARGE raced forwardly along inside into stretch, failed to threatened. OKIE RIDE was outrun. RICHMOND showed little. WICKED B. HAVIOR was never close.
