HEZA WILD GUY chased leaders along inside from start, responded to take over after a half, kept to steady urging during stretch drive and prevailed. PRECIOUS COLONY within striking distance from outside, responded to handily in drive but unable to match strides with winner although much clearly best of others. SLEW BY SLEW stalked leaders throughout, raced three wide into stretch, lacked response in drive. GRANDA TORMENTA trailed for half, finished with a belated rail rally. WAIT IN LINE sent to front, set pace for half, gave way in lane. MAJOR REALITY raced evenly throughout. VOW TO GREATNESS was never a factor. PASS THE BISCUITS was always outrun.
