ON A BURNER was never far back along inside, commenced bid by smartly coming to rail entering stretch, responded to strong handling, gained nod and drew clear in late going. LINDA CAROL'S SLEW chased pace from outset, responded to gain nod mid stretch, went gamely to wire before weakening in final stages. INDY TRUCKER dueled on the outside of rivals from start, responded to gain narrow edge at the half, went gamely into stretch, tired in drive. SUB RIVER well back at the half, passed tired foes. FIN DOCTORE well back at the half, lacked response when asked. ANARCHY was never far back

outside rivals, had no rally. IT'S ON HOLMES raced in middle of pack, came four wide into stretch, lacked bid. FATHER JESS well back at the half, failed to menace. FRONT LINE LAWYER raced wide into first turn, showed little. LA SWIFT raced wide into first turn, not a factor. MAE'S RACER was never a threat. ECHO MIKE was outrun. KING'S APPROVAL was never close. STANS MR. BUSTER hustled to front, dueled for half, stopped.
