ANTIOCH DIAMOND was never far back, came three wide into lane, rallied between foes, got up in final strides. WHOLELOTATRICKS within striking distance along rail from start, responded to gain narrow nod between calls near wire, outnodded in a gallant effort. OUTFITTER stalked leaders while on the outside, came five wide into stretch, gained nod mid stretch, outfinished. LYDIA'S LAST STEP raced in middle of pack to stretch, finished with a belated rail rally. MIDLAND MAN hustled to front, dueled to mid stretch, gave way. ZAVATA FLASH dueled from start outside rivals, gained nod at the half, gave way in lane. DISTINGUISH raced six wide into stretch, failed to threatened. DAWN OF A NEW DAY was outrun.
