SEA OF DREAMS broke alertly from the outside, chased leader into stretch, responded to gain nod mid stretch, drew off in late going. FRIENDLY SUMMER within striking distance along inside to far turn, came four wide into stretch, responded to handling, got up for place in final strides. OKIE CITY GIRL allowed to settle for half, circled leaving far turn, six wide into stretch, finished well with mid track rally. ISLAND ARTIST stalked leaders from outset, lacked late kick in drive. REFUSED TO COMMIT raced along inside, failed to menace. DREAM BELIEVER forwardly positioned along inside into stretch, had no rally. JET'S ATTACK trailed for half, passed tiring foes. SWITCHED ON hustled to front, set pace for half, gamely to mid stretch, gave way. BEAUTIFUL SIMONE was never a factor. RUNAWAYREBEL never seriously threatened.
