QUE PASO rated off early pace, circled five wide into stretch when making bid, responded to steady handling in drive, got up in time. DENIA'S CHIEF within striking distance along inside throughout, went gamely in drive but unable to reach winner in drive. CATRIN stalked pace throughout, lacked needed late kick in drive. TANALIAN vied for lead from start, gained advantage at the half, tired in drive. HARPER'S ILE failed to menace. SENIOR saved ground, was not a factor. PUTTHEHAMMERDOWN chased pace into stretch, gave way. JERI HARPER was always outrun.
