KENTUCKY GEM dueled on the outside of rivals from start, responded to handling, took over mid stretch, kept to task while drawing clear to wire. SILK SIDE SUSAN dueled along rail from outset, gained narrow edge at the half, no match for winner in drive but well clear of others to wire. RUN KATNISS was never far back, came four wide into stretch, finished with a mild mid track rally to gain show spot. HILDA TENORIO (MEX) within striking distance along inside for half, had no rally. MI TORMENTO (MEX) raced five wide from off pace into lane, failed to menace. CACTUS DAWN dueled while racing between rivals for half, gave way. CHASING TORNADOS was never a factor. BAR HOP was never a threat. SPECIAL I BELIEVE forward to steadily when in tight quarter early, dropped back.
