UNBRIDLED SHERIFF benefited going into first turn while moving to front, held clear advantage into stretch, kept to task in drive, remained well clear to wire. LEGAL CITIZEN off slow, moved up along inside into far turn, came three wide into stretch, went gamely but was no match for winner but clearly best of others. TORNADO RUN stalked leaders along inside into stretch, lacked needed response in drive. ICY BLIZZARD chased leaders into stretch, tired. RIVER RIDGE raced evenly throughout. WOULD YOU failed to menace. ANDRETTI never threatened. CACTUS SON carried wide into first turn, raced forwardly for half, gave way. ONE HELLUVA RIDE broke to front, drifted outward badly first turn, dropped back. SWEET WATER'S BOY carried wide into first turn, dropped back.
