U S C FIGHT SONG was allowed to settle in stride for half, came around rivals leaving far turn, split foes when making bid into stretch, responded to steady handling, got up in time. BARRAAQ well back along inside for half, moved up outside of rivals leaving far turn, came four wide into stretch, responded to handling and finished with a solid belated rally but too late. SOUTHERN CAUSEWAY was never far back, moved up along rain into stretch, loomed danger mid stretch, went gamely to wire before weakening late. ZEE ARE ONE forwardly positioned while racing mid pack leaving far turn, came five wide into lane, had no rally. STILLWATER SLEW rushed to front along rail, set pace to mid stretch, tired. RED SHOES chased pace to mid stretch, gave way. MONEYONTHEGRASS vied for lead along inside for three quarters, gave way. OUI OUI JAZZY raced along inside, failed to menace. B G ROYAL WEST was never a factor. SIGHTLINES forwardly positioned outside rivals for half, faded, vanned off. HIS FOREST MAJESTY dueled on the outside of foes for

half, faded steadily thereafter. SHY KITTEN was never a threat and vanned off after running.
